Agenda Item no. 4 Appeal cases received from Universities

NCEAC General Council reviewed the appeal cases received from Sukkur IBA and Bahauddin Zakariya University, Multan.

NCEAC General Council found no ground to review the previous awarded categories to above mentioned institutes and upheld the same categories awarded in 27th NCEAC General Council Meeting.

NCEAC General Council also suggested both institutes to apply for re-accreditation.

Agenda Item no. 5 Accreditation of BS (Software Engineering) program of Army Public College of Management Sciences, Rawalpindi

NCEAC General Council reviewed the case of accreditation of BS (Software Engineering) program, received from APCOMS, Rawalpindi.

Case was discussed in meeting thoroughly and resolved that NCEAC should not send its Accreditation Inspection Committee to APCOMS, Rawalpindi for the accreditation of BS (Software Engineering) program.

Agenda Item no. 6 Revision of Accreditation Fee

After detailed discussion, it was decided that accreditation fee for a single program will be increased from Rs. 150,000 to Rs. 200,000, for applications received on or after 1st September 2018.

Agenda Item no. 7 Accreditation of BS (Cyber Security) degree program of Air University, Islamabad Campus

It was decided that NCEAC should visit and accredit this Computing program provided:

- 1. Program name is listed in the Pakistan Qualification Register (PQR)
- 2. HEC has approved this degree program, and also issued NOC to start the program
- 3. National Curriculum Review Committee (NCRC) has not approved curriculum for this program.

Agenda Item no. 8 Students Registration Policy

Dr Muhammad Ali Maud presented a revised Students Registration Policy before the council. It was resolved that Students Registration Policy needs more brainstorming, A two member committee, with the following as its members, was constituted.

Committee will present an improved version of the 'Students Registration Policy' to the council in its next meeting.

Agenda Item no. 9 Revision of NCEAC Field Audit Form

NCEAC General Council has approved the revised Criteria Verification Form with some changes. Approved NCEAC Criteria Verification Form is attached as annexure 'A'.

Agenda Item no. 10 Any new matter with the permission of Chair

- It was decided that awarding of categories was not suitable, as it led to some misuse by the universities. It was decided to do away with categories (W, X, Y & Z), and that these may be replaced with accreditation of whether 3 Batches, 2 Batches, or 1 Batch. In certain cases, the program may be placed on probation period accreditation.
- It was decided that the appeal cases should not be discussed in the General Council meeting. If an institute desires, NCEAC will revisit the institute before expiry of its accreditation period. For re-visit institute must pay 50% of the accreditation fee and a one senior member will re-visit the institute.
- NCEAC service structure was discussed in the meeting and a committee, comprising the following two members was constituted by the Council.
 - 1. Dr Shoab A Khan
 - 2. Dr Zartash Afzal Uzmi

Committee should present their recommendations in the next Council meeting for approval.

- It was decided that, if an affiliated institute applied for accreditation, then Registrar of the affiliating University should be included in the NCEAC visit committee during the visit of the affiliated institute.
- It was suggested that the name of the affiliated institute should be included in the transcript of the graduates of that institute.
- It was discussed that instead of different Computing degree program names, institutes should offer one degree BS Computing with specialization of Computer Science, Software Engineering etc.
- Dr Jamil suggested to include extra curriculum activity point in the Criteria Verification Form.
- It was suggested that Pakistan Software Export Board (PSEB) should nominate a person for local visits. NCEAC evaluation team shall inform the department before visit to coordinate with PSEB for students' placements.
