Agenda Item No.5 Action Report-Summary of accredited programs and applications Received

Summary of accredited programs and applications Received was presented and discussed. The same is sent herewith for the record and information of the members of the Council.

The Chairman apprised the members that Council's website lists all accredited programs with the categories assign to each Program. It was suggested by few members that instead of listing the categories, the Council should only mention whether the program is being accredited or not or should only mention the years for which the program is being accredited. The rational presented was that all universities should get good students. Arguments were made for and against the suggestion and finally majority of the members decided to keep the category on the website and not to publish it in the newspapers.

Agenda Item No.6 Action Report- Seminar by Dr. Mudassar Wyne, Commissioner, ABET, USA

The Chairman apprised the member about the seminar being conducted by Dr. Mudassar Wyne who came in private capacity. The seminar was very useful and many members and evaluators attended the seminar.

Agenda Item No. 7 Action Report-Meeting of Councils

The Chairman apprised the members about the 3rd Meeting of all the 13 Accreditation Councils of Pakistan. The objective was to bring uniformity in the process across different accreditation councils.

Agenda Item No. 8 Consideration of Proposal regarding introduction of Zero/pre-accreditation visits-Letters from GIK Institute and CESET

The Chairman apprised that few institutions are asking for zero visits before they start a computing program. Dr. Ayub Alvi opposed the idea and mentioning the flaws in zero visits conducted by PEC and suggested that visits should only be made after a program starts and students are being inducted. Dr. Shoab proposed that a visit should only be made to guide the institution and not to inspect them.

The Chairman requested Dr. Syed Mansoor Sarwar to look into the matter and work on the details.

Agenda Item No. 9 Consideration of Proposal by Dr. Fakhar Lodhi for Organization and Meeting of all approval Program Evaluation and Estimated Budget Required

The Chairman suggested that one day training should be arranged for the evaluators preferably in summer break in July. The workshop should be for a day or two and the Council should try to get the maximum evaluators in the workshop. Mr. Fida Hussain apprised the Council that HEC is organizing a workshop of QAA UK in April and Council is invited to send its members and evaluators to the workshop.

Agenda Item No. 10 Progress of the Committee on Media Promotion and the Suggestions being made in the regional meetings

The committee members for the tasks still need to work on this item and a report will be presented in next Council meeting.
