d. Renaming of Council: Notification of the decision made in 16th Meeting of NCEAC for renaming the Council as Pakistan Computing Council

In 16th NCEAC Meeting, the members unanimously agreed to maintain the decision made in 15th Meeting regarding the renaming of the Council from National Computing Education Accreditation Council to Pakistan Computing Council (PCC).

The Chairman apprised the members that the same was referred to DG, QAA-HEC for consideration, deliberation and notification by HEC. Response was received from DG, QAA stating that the matter has already been decided in the 19th Higher Education Commission dated June 27, 2012 which is as under for information and reference

*“The Commission desired that the word **“National”** may be added in the beginning of the title of all professional Councils already established or to be established by the HEC.”*

Resolution No. 17.6.4.13.d: It was suggested that the Council be re-named as “National Computing Council”

Agenda Item No. 7: Any new matter with permission of the Chair

The following decisions were also taken in the meeting:

- a. The members did not approve association of NCEAC with the Conference being conducted by Indus Institute of Higher Education, Karachi.
- b. The Council approved that the increased ‘Accreditation Inspection Fee’ of Rs. 150,000 should be applicable from 1st July 2013 (rather than 1st April 2013). A letter about this concession should be sent to all universities for information and appropriate action.

The meeting ended with a Vote of Thanks to the Chair.
