**Agenda Item No. 3                      Action Report-Publication of ad regarding Public Alert in national newspapers**

**Resolution No. 20.3.11.14:**                      The following recommendations were made by the members to enhance response of institutions for accreditation of computing programs:

1. A notice of non-accredited institutions be published to give a cut of date (June 2015) for submission of applications for accreditation of their respective computing programs without mentioning the names of the institutions.
2. Affiliated Institutions are required to seek accreditation individually and are not automatically accredited due to accreditation of their parent institutions.
