Agenda Item no. 4 Service Structure of NCEAC Secretariat

Council decided to consult with the HR department of HEC regarding the service structure of NCEAC staff.

Until the final decision, council approved the rules attached as annex 'A'.

Agenda Item no. 5 Accreditation of Passed-out Batches

Council decided that, NCEAC will consider accreditation of only those graduated batches, whose previous and later batches were or are accredited.

NCEAC will not entertain applications for accreditation of the already graduated batches.

Agenda Item no. 6 Appeal cases received.

Appeals to upgrade the category awarded to them were received from the following three institutions.

- 1. Sukkur IBA, Sukkur
- 2. Iqra National University, Peshawar
- 3. National University of Computer and Emerging Sciences-FAST, Lahore Campus

These were discussed; and the Council decided as follows:

- Council upheld the categories awarded to the three institutes, in its previous (26th) meeting. Council reiterated that category is decided on the basis of assessment by its Program Evaluators, based on the observations and evidence noted at the time of their visit.
- Council noted and appreciated the improvements made by these institutes, after the Accreditation visit.

Agenda Item no. 7 Composition of Accreditation Inspection Team

Representatives of the IT industry, who were attending this meeting, desired to be included in the NCEAC accreditation teams visiting the universities.

The Council decided that initially a local industry representative will be invited to accompany NCEAC Accreditation Inspection Committee (AIC) visiting universities located in Islamabad, Lahore and Karachi. The Council will then discuss the impact of presence of industry representative in the AIC in its meeting.

Agenda Item no. 8 Revision of Accreditation Fee

After detailed discussion, it was decided that the accreditation fee for a single program will be increased from Rs. 150,000 to Rs. 200,000, for applications received on or after 1st January 2018.

Agenda Item no. 9 Revision of Honorarium

Council decided no increase in current honorarium of Rs. 10,000.

Agenda Item no. 10 One time Accreditation (PNEC, Karachi)

After detailed discussion it was decided that the BS (Management Information System) program of the Pakistan Navy Engineering College (PNEC), Karachi which is currently accredited by NCEAC will not be entertained in future for accreditation, because of the following reasons:

- a) HEC has not prescribed curriculum for such a program.
- b) This program may be under the purview of National Business Education Accreditation Council (NBEAC).

Agenda Item no. 11 Any new matters with the permission of Chair

- a. It was decided that if an institute apply for more than one program at a time then different teams will visit the institute for different programs at the same time.
- b. It was suggested that institute may offer a course to industry rep to produce linkage between academia and industry.
- c. It was suggested that the personal information of the Students and Faculty will not be uploaded for general public.

They shall be governed by the following rules and regulations, subject to any revision, from time to time.

LEAVE RULES

- 1. Staff salaries shall be subject to renewal every year on 1st January, to be decided on the basis of their performance, and increase in cost of living.
- 2. Staff shall be entitled to 12 (twelve) days of casual leaves in each calendar year.
- 3. Staff shall be entitled to 12 (twelve) days of medical leaves in each calendar year.
- 4. Those joining the organization during the year shall be entitled to pro-rata number of leaves.
- 5. Staff shall be entitled to 15 (fifteen) days of earned leaves upon completion of each year of service. Earned leaves can be accumulated for a maximum of 45 days. Earned leave will not be granted for less than seven days (one week).
- 6. Additional leaves shall be without pay.

GRATUITY

- 7. Staff shall be entitled to gratuity upon leaving NCEAC, which shall be equal to one month's salary for each completed year of service. For the purpose of working out the gratuity, monthly salary shall be the average of salary paid for the most recently completed twelve months.
- 8. Gratuity becomes payable at the time of separation from services which could be:
 - i. by resignation by the employee,
 - ii. termination of services by employer due any reason other than misconduct (in case of proved misconduct employer is not bound to pay gratuity),
 - iii. in case of death, and
 - iv. retirement or superannuation of employee
- 9. Gratuity shall be paid upon clearance of all matters with NCEAC.
